These Terms ("Terms") inform our users ("you") about how they can use the Stride mobile application (the "Application"), our website located at stride.social (the "Website"), and all related services provided by Stride ("we" or "us").

By using Stride, you agree to these Terms. To ensure your agreement, you will be asked to expressly consent by ticking a box when creating a user account ("Account").

If you do not agree with these Terms, or if you cannot or do not wish to comply with them, please do not use the Application, access our Website, or use any of our services.

#### Who Are We?

Stride is developed by Stride Labs L.L.C.-F.Z., located at The Meydan Hotel, Grandstand, 6th floor, Meydan Road, Nad Al Sheba, Dubai, U.A.E, P.O. Box No: 9305, and registered with the Meydan Free Zone.

### **Before Using Stride**

- Stride rewards your daily sports activities. The Application uses your phone's pedometer to convert your steps into points, which can be exchanged for rewards.
- To use Stride, you need a compatible phone with a functional pedometer, Internet access, and a Stride Account.
- Stride collects data such as the number of steps and geolocation, with your consent. Without access to these data, we cannot provide our services.
- Users under the age of 15 cannot use Stride. We ask you to confirm your age when creating an Account.

### Is Using Stride Free?

Access to and use of Stride are currently free. Paid features may be offered in the future.

#### **How to Access Stride?**

Download Stride from the Apple App Store or Google Play Store, accepting their terms of use. Log in via a Google account or by entering an email and password. You are responsible for keeping your login credentials confidential.

#### What Does Stride Do for Me?

In summary, Stride allows you to:

- Earn points by walking, watching ads, referring friends, or completing challenges.
- Participate in a leaderboard and convert your points into cash, promotional codes, or support for charitable or associative projects.

### **Usage Rules**

It is prohibited to use Stride to harass, threaten, or incite violence. Fraudulent behaviors, creating multiple accounts, or commercial use of Stride are also prohibited.

All elements of Stride, including trademarks, content, and software, are protected by intellectual property rights.

We do not guarantee the absence of errors or interruptions in the use of Stride. Rewards and features may change at our discretion.
