Commercial Use License

This Commercial Use License ("License") is entered into between Rip ("Licensor") and the token owner ("Licensee"), collectively referred to as the "Parties."

Grant of License:

Licensor grants Licensee a non-exclusive, transferable, worldwide license to use and exploit video content owned or controlled by Licensor for commercial purposes, specifically related to surfing and associated activities. This license includes the right to reproduce, distribute, publicly display, and create derivative works based on the video content. If the NFT is transferred, your rights to the license is revoked. For example if you use the video on a blog and wish to resell the token, you will need to remove the content from said blog or social media.

Permitted Use:

Licensee may use the video content for the following purposes:

- Incorporating the video content in promotional materials, such as advertisements, marketing campaigns, and social media content, specifically related to surfing.
- Displaying the video content on Licensee's website, for promotional purposes.
- Presenting the video content at trade shows, conferences, and other similar events to promote Licensee's brand and services.
- Licensing or sublicensing the video content to third parties for purposes consistent with this License, subject to the prior written approval of Licensor.

Attribution:

- Licensee shall provide appropriate attribution to Licensor for the use of the video content. The attribution shall include the name "Nic Von Rupp" and the company name "rip.xyz" prominently displayed alongside the video content or in accompanying materials, as reasonably determined by Licensor.

Restrictions:

Licensee shall not:

- Use the video content in a manner that is defamatory, obscene, or illegal.
- Sell, sublicense, or transfer the video content to any third party without prior written consent from Licensor.
- Use the video content in a manner that implies endorsement, sponsorship, or association with Licensor, unless express written permission is granted.

Intellectual Property Rights:

Licensee acknowledges that Licensor retains all rights, title, and interest in and to the video content, including any intellectual property rights associated with it. This License does not grant Licensee any ownership rights or intellectual property rights over the video content.

Term and Termination:

This License shall be effective as of the date of execution and shall remain in effect until terminated. Either party may terminate this License upon written notice if the other party breaches any material provision of this License. Owner of the NFT can demonstrate termination of license by burning. Upon termination, Licensee shall cease all use of the video content and return or destroy any copies of the video content in its possession.

Governing Law:

This License shall be governed by and construed in accordance with the laws of [State/Country], without regard to its conflict of laws principles.

Entire Agreement:

This License constitutes the entire agreement between the Parties concerning the subject matter herein and supersedes all prior or contemporaneous negotiations, understandings, or agreements, whether written or oral, relating to such subject matter.
